About MANAVLOK

MANAVLOK is a Voluntary organization for socio-economic upliftment of the rural-poor, established in 1982 under Society Registration Act 1860. A several experiments in rural development was launched for the Last 33 years, MANAVLOK would develop its activities over an increasing scale, never straying from the tenet that programs be based on the specific needs of the people. The Ongoing activities of the organization are Community based Monitoring programme of NRHM, Water shed development programme, Krushak Panchayat, HelpAge India Programme, Know your customer Programme, Manaswini Mahila Parkalp (Women empowerment providing Shelter Home, Free Legal aid center, training center), Domestic Violence and Gender Sensitization, Jansahayog, Social Work College, SHG's, Need based Training Centre, sanitation, relief services for the victims of Natural Disaster, advocacy, monitoring and evaluation of Govt. program's. We are permitted and authorized by government of Maharashtra to run schools.

Historical Perspective :

In the early 1970s, a socialist group of youth began seeking solutions to social and political problems of the rural community with the general aim of achieving a harmony society and fullness of life. After nearly 20 years of effort and agitations, they concluded that socio-political change was not possible without economic change. With this point of view in mind, they established **MANAVLOK** in 1982, a voluntary organization for the socio-economic upliftment of the rural poor.

Philosophy :

MANAVLOK'S CREED: "GO TO THE PEOPLE, LIVE AMONG THEM, LEARN FROM THEM, LOVE THEM, START WITH WHAT THEY KNOW, BUILD ON WHAT THEY HAVE."

Manavlok's philosophy is reflected in its name: MANAVLOK, which is the shortened form of "<u>MA</u>rathwada <u>NAV</u>nirman <u>LOK</u>ayat", where 'NAVNIRMAN' means "Creation" and 'LOKAYAT', denotes "People's opinion". Manavlok thus symbolizes a new idea or an experiment in rural development, whereby villagers themselves are the focus of action and control. VISION :

MANAVLOK aims to solved the socio-economical problems of the community and achieve a better life to them.

MISSION:

MANAVLOK believes that collective local leadership plays an essential role in mobilizing the local resources and making the best use of them. The utilization of local human resources must take priority over the hiring of outside assistance. MANAVLOK does not entertain the welfare approach of given aid. It believes in providing the means for development rather than dolling out money to the poor. Funds are thus directed at start- up projects, with the expectation that beneficiaries contribute an equal investment in time and energy.

MANAVLOK believes that women play an important role as men in society and yet continue to be marginalized, impoverished, and under represented. Special attention must be given to their development. The special women oriented project "**Manaswini**" means one who propagates her own enlightenment with grit.

MANAVLOK acknowledges that the health of the people is ultimately dependent on the health of their environment. As such the land must be protected from modern petrochemicals and devastation. Since ignorance and poverty are enemies of the environment, awareness programs and development schemes are seriously promoted.

- 3. To improve health conditions in the region.
- 4. To improve the standard of formal and non-formal education and increase the academic standing of students.
- 5. To build democratically working transparent organizations of rural poor, women and youths to solve their own problems locally.

About College :-

Our source of inspiration is Dr. D. S. Lohiya alias Babuji who has been working in the field of social development especially rural development since 1972. He felt that infrastructure of Manavlok experiments' can lead to good source of social work training. **Thus MANAVLOK's College of Social Work** established in 1999, to impart quality training in professional social work among the trainees to fulfill the requirements of the developing fields of social work leading to the Post Graduate degree in Social Work (MSW) of the Dr. Babasaheb Ambedkar Marathwada University, Aurangabad.

The college is located in specious campus of 8 and half acres, which provides good learning environment to students. A special attention is given towards personality development of student by providing opportunities to participate in competitions, seminars etc.

- College Entrance Test (CET) : Test shall be conducted in two parts i.e. written test of – 80 marks and personal interview – 20 marks, Total 100 marks.
- Written test shall consist of 60% objective type / multiple choice questions and 40% descriptive questions.
- **Syllabus for CET** –the Syllabus for entrance test shall consist of Social reformers, social problems, social legislations, social movements, General Knowledge and current issues etc.

- **A.T.K.T.-** A candidate who has passed the 75% of the papers at the first year (first & second semester) examinations shall be allowed to take admission in third semester.
- **Attendance :-** Every student for maintaining and adequate performance shall put in at least 75% attendance in theory paper and 90% attendance in social work practicum is compulsory.
- J) Courses :
 - Core Course (CC) : A core course is a course that a student admitted to M.S.W. P.G. program must successfully complete as core requirement, to receive the degree. Each core course shall have 03 credits.
 - Foundation Course (FC) : The course that based upon the content that leads to knowledge enhancement.
 - Elective Course (ECSW) : Elective course is a course which can be chosen from a pool of papers from the basic subject or specialization.
 - Each student shall have to select the elective courses from the list of electives I to IV immediate after the completion of admission process, so as to commence the curriculum of elective courses from I to IV semester.
 - Minimum intake of each elective course should be ten.

Orientation Visits :

Orientation visits is a compulsory activity organized in the beginning of the 1st and 3rd semester. To give exposure of various welfare and developmental service organizations to the students the orientation visits are arranged. It is aimed to provide an exposure and understanding of the services provided in response to people's needs. The objective of this orientation visits is to orient the student about structures and functions of various govt. and non govt. agencies. Minimum seven orientation visit in 1st semester and minimum 05 orientation visits based on the elective course in 3rd semester.

Concurrent Field Work :

Concurrent fieldwork is an ongoing central learning opportunity, to develop understanding and intervention skills among students in reality situations. Field work is an internal part of training in social work. Students shall be placed in appropriate agency / field work concurrent field work and she / he shall have to put in 15 hours of field work per week including individual conference, Group conference and Report writing etc. Minimum 5 hours exposure of concurrent field work on each field work day shall be arranged for.

communication skills:

In this exercise a group of students shall select a theme with social work approach and compose a script and present it to communicate selected messages aimed at to bring about desired changes in mindsets of targeted section of community.

Rural Camp/Extension Work :

Rural camp is compulsory 5 days activity for MSW IInd Semester students. In this camp provides opportunities to experiences rural life, analize rural dynamics and observe the local self government and voluntary organizations. It also helps develop skill carry out, evaluate and report the experience.

Study Tour /Extension Work :

Study Tour of M.S.W. IVth semester students shall be organized for 5 days during 4th semester to the innovative social work projects. The agency visits shall be based on the elective courses chosen by the students. The students shall prepare the reports, on the agency visits during study tour. In unusual situation, extension activity shall be organized in place of study tour.

Viva :

• At the end of Ist and IVth semester the viva-voce on orientation visits and concurrent fieldwork shall be conducted by internal and external examiner, to assess the performance on knowledge and skill basis.

- Out of the total 25 marks of viva-voce, 10 marks shall be for Orientation Visit Viva and 15 marks for concurrent fieldwork viva.
- The viva-voce on Social Work Practicum at the end of Ist semester shall be conducted by the internal and external examiner.
- At the end of IInd and IVth semester a comprehensive viva-voce examination shall be conducted by panel of examiners appointed by the University along with internal examiner, based on social work practicum of Ist and IInd sem and IIIrd and IVth semester respectively.

Research Project:

Every student shall complete a research project, commencing at the IIIrd semester and ending at the IVth semester.

Conduct of Research Project. :

- Every student is required to select a topic for research related to the social problems and areas of social work at the end of IInd semester and follow the scientific process and methods of social work research and social research.
- At the end of IVth semester, the research project shall be submitted in 2 copies, one copy of project signed by the principal shall be returned to the students before the schedule of external assessment & viva-voce.
- The Research project shall carry in all 150 marks having internal assessment for 100 marks.
- A viva-voce of 50 marks shall be conducted by external examiner panel of university.
- In case the student does not perform for research project in regular time schedule, she/ he shall be allowed to complete the research project within forth coming academic year.
- In case a student fails to fulfill the academic requirements to pass in research project, such students shall have to seek fresh admission by depositing the fees for admission, research project and identity card.

Block Placement (Vocational Training) :

Candidate shall be required to complete one month's Block Placement within 40 days after examinations of IVth semester and produce a report of work done certified by the concerned organization. It carries 6 credits.

Evaluation Method:

The evaluation of each of the components of M.S.W. Course i.e. Theory Course (TC), Social Work Practicum (SWP), learning supportive activities (LSA) and Research Dissertation (RD) shall be done internally and externally. The details of each of the component shall be as follows :

• **Theory Course:** Each theory course shall be of 100 marks, divided into internal examination (Sessional/Test of 20 marks and semester end examination of 80 marks.)

- Internal Examination: There should be 2 mid semester examinations, 1st based on 40% portion taught and the 2nd on 60% portion taught of each course. The subject teacher shall conduct this exam and average score obtained out of 2 mid semester examinations may be considered for the preparation of final marks / grade.
- Term End Examination (20 + 60): Each theory course question paper shall consists of 2 sections. Section A (20 Marks) shall be objective types, carrying 2 3 marks of each question (i.e. fill in the blanks, multiple choice questions, match the column, true of false, answer in one sentence, covering entire syllabus.) It is compulsory to attempt this section for the all students.
- Section B shall carry 60 marks consisting 7 questions out of which any four shall be attempted.

Learning Supportive Activity (LSA) :

It comprises of seminars, outreach activities, presentations, fieldwork, assignments, case study, research outline, issue base seminar, surprise test. The LSA incharge shall design the activities of Ist to IVth semester considering the course content of the semesters. The students are allotted among the teaching faculties for the conduct and assessment of such activities. The record of LSA activity of such allotted students is mandatory. The concerned teacher shall decide the LSA activity and maintain the record. The total marks of LSA from Ist to IVth semester = 50.

(Ist Sem. – 10 Marks, IInd Sem. – 10 Marks, IIIrd Sem – 20 Marks, IVth Sem – 10Marks = 50 Marks.)

- Field Based Research Project (PR) : 100 Marks (Internal) The research project shall be field based.
- Viva on Research Project : 50 Marks External In order to have 100 percent impartial and transparent evaluation at different levels of MSW training the given formats for evaluation of each components of social work practicum, are to be used.

- Viva-voce on Research Dissertation (External Assessment)
- Viva-voce on Social Work Practicum IInd and IV semester. (External Assessment)

Grade Awards :

• A ten point rating scale shall be used for the evaluation of the performance of the student to provide letter grade for each course and overall grade for the Master's Programme. Grade points are based on the total number of marks obtained by him/her in all the different heads of examination of the course. These grade points and their equivalent range of marks are shown separately in Table - 1.

- Non appearance in any examination / assessment shall be treated as the student has secured nil marks in that subject examination / assessment.
- Minimum D grade (4.00 grade points) shall be the limit to clear / pass the course / subject. A student with F grade will be considered as 'failed' in the concerned course and he / she has to clear the course by reappearing in the next successive semester examinations. There will be no revaluation or recounting under this system.
- Every student shall be awarded Grade points out of maximum 10 points in each subject (based on 10 point Scale.) Based on the Grade points obtained in each subject, Semester Grade Point Average (SGPA) and then Cumulative Grade Point Average (CGPA) shall be computed. Result will be announced at the end of each semester and cumulative Grade card with CGPA will be given on completion of the course.
- Computation of SGPA (Semester grade point average) & CGPA (Cumulative grade point average)

Award of Degree :

- A candidate who has successfully completed all the core courses. Foundation and Elective/Specialized courses and social work practical research dissertation and service course approved by the University for the programme with prescribed CGPA shall be eligible to receive the degree of M.S.W.
- Every student will have to complete at least 129 credits to obtain the masters degree in Social Work out of which 125 credits shall be from their respective subject and four credits from service courses.

Grade Card:

• The University shall issue at the beginning of each semester a grade card for the student, containing the grades obtained by the student in the previous semester and his Semester Grade Point Average (SGPA).

Other curricular activities

- **Field Action:-** The college launches field action project in the communities on different social issues. such as education to right, survey, movement against corruption etc. student and faculty are actively participated in field action.
- **Extension Activity:** With the collaboration of Dr. Babasaheb Ambedkar Marathwada University Aurangabad the college has started Adult, Continuous and extension services department from 2003. Under the department, various activities are taken by the faculty for the college students and community.
- Seminar and Group Discussion :- Student will take a selected topic for seminar and he / she has to present in the class room and group discussion will be organized once in a month for sharing of students, views, ideas and current social issues.
- Collaboration and co ordinations:- College has collaborated with local organization and association for facilitating services to the community. Domestic, worker association, women, pensioners association, Andhashradha Nirmulan Samittee, Muslim Vikas Parishad, Labour Union at Sugar factory and Manavlok etc.
- **Community Services:** SHG formation, Association of farmers and youths, associations of domestic workers (Women), association and coordination with Hamal Mapadi organization, pensioner association etc.

Govt. of India Scholarship :-

Students who are reserved categories, physically handicapped and minorities' categories can apply for Govt. scholarship. Students should be fill up the form and submitted to the office within end of the August. If the students are not submitted within the time, the university fees will be paid last week of August.

Vidya Vetan :-

Govt. has sanctioned the vidya vetan scheme for professional course, for backward categories. Those students are living the outside of the govt. hostel they have to fill up the Vidya vetan form and submit to the office in the month of August.

Freeship form :-

The freeship scholarship is only for the son/daughter of primary teacher. Students should be fill the freeship form and submitted to the office.

Exam cell :-




